THE EMERGENCY LAWS (TRANSITIONAL PROVISIONS)
(CYPRUS) ORDER, 1946.

ORDER MADE UNDER DEFENCE REGULATION 40.

In exercise of the powers vested in him by Defence Regulation 40, as set out in the Schedule to the Emergency Laws (Transitional Provisions) (Cyprus) Order, 1946, which continues to be in force by virtue of the Emergency Laws (Miscellaneous Provisions) (Cyprus) Order, 1955, His Excellency the Governor by this Order declares that the areas set out in the Schedule hereto shall, until further Order, be protected places for the purpose of the said Regulations and that, save with the permission under the hand of the General Officer Commanding, Cyprus District or any officer authorized by him in that behalf and, subject to such directions as may be contained in the permission, no person shall be in such places.

2. A copy of this Order shall be posted on Notice Boards placed at or near the areas affected thereby.

SCHEDULE.

1. *Famagusta District.*

(a) All that area situated at the locality "Karaolos" in Ayios Loukas Quarter, Famagusta Town, that is to say:—

THE LAND ACQUISITION LAW.

CAP. 233 AND LAW 26 OF 1952.

NOTIFICATION UNDER SECTION 7.

Whereas by Notification published under No. 68 in Supplement No. 3 to the *Gazette* of the 13th February, 1952, as amended by Notification No. 362 in Supplement No. 3 to the *Gazette* of the 3rd May, 1956, His Excellency the Governor declared under sections 2, 3 and 5 of the Land Acquisition Law the establishment and maintenance on a better basis of an airfield and camps and other installations appurtenant thereto in or near the villages of Yerolakkos, Ayios Dhometios, Engomi, Kato Lakatamia and Paleometokho in the District of Nicosia, to be an undertaking of public utility ;

And whereas the Commissioner of Nicosia and Kyrenia by notice published under No. 476 in Supplement No. 3 to the *Gazette* of the 7th June, 1956, gave particulars of the lands (hereinafter referred to as "the lands") required in connection with the aforesaid undertaking ;

And whereas the Commissioner forwarded to the Governor the required recommendations, plan and particulars, no objections to the proposed acquisition having been made ;

And whereas the Governor has approved the plan and particulars submitted and has considered it expedient, having regard to all the circumstances of the case, that the lands be acquired ;

Now, therefore, in exercise of the powers vested in him by section 7 of the Land Acquisition Law the Governor, has been pleased to sanction the acquisition of the lands, under the provisions of the said Law.

THE SHEEP AND GOATS (SHEPHERDS' LICENSING AND CONTROL) LAW.

CAP. 157.

NOTICE UNDER SECTION 12.

In exercise of the powers vested in me by section 12 of the Sheep and Goats (Shepherds' Licensing and Control) Law, I hereby direct that, until this notice is revoked, during the period between 1st August and the 30th November every year, flocks within the area of Ayios Iakovos village and Plousha Minor forest in the District of Famagusta, shall between the hours of sunset and sunrise, be kept inside an enclosure and not taken outside an enclosure :

Provided that nothing in this notice contained shall prevent the driving of any flock under the proper charge of a licensed shepherd from one village area to another, along any public road at any hour.
