BYE-LAWS MADE BY THE MUNICIPAL CORPORATION OF LEFKA.

In exercise of the powers vested in them by the Municipal Corporations Law and of every other power thereunto enabling the Council of the Municipal Corporation of Lefka hereby make the following bye-laws :—

i. These bye-laws may be cited as the Lefka Municipal (Amendment) Bye-laws, 1956, and shall be read as one with the Lefka Municipal Bye-laws, 1940 to 1955 (hereinafter referred to as " the principal Bye-laws ") and the principal Bye-laws and these bye-laws may together be cited as the Lefka Municipal Bye-laws, 1940 to 1956.

2. Bye-law 139 of the principal Bye-laws is hereby deleted and the following bye-law substituted therefor :—

" 139. With effect from the 1st January, 1957, the following rates shall be paid by the owner or occupier or lessee of any premises or building or place supplied with town water, that is to say :—

3. Paragraph (1) of bye-law 213 of the principal Bye-laws is hereby deleted and the following paragraph substituted therefor :—

" 213.—(1) Every licensee of a hotel of any class shall pay a fee of 10 mills per day or part of the day to the Municipal Clerk and Treasurer for every person of over ten years of age in respect of every night or part thereof on which such person is provided with sleeping accommodation at such hotel "

THE IRRIGATION (PRIVATE WATER) ASSOCIATION LAWS, 1949 AND 1954.

In pursuance of the provisions of sub-section (3) of section 12 of the Irrigation (Private Water) Association Laws, 1949 and 1954, the following Rules made by the Committee of the Irrigation Association of Philia "Dexameni tis Kannouras", in the District of Nicosia, are published in the *Gazette*.

IRRIGATION ASSOCIATION OF PHILIA "DEXAMENI TIS KANNOURAS".

Rules.

1. These Rules may be cited as the Irrigation Association of Philia "Dexameni tis Kannouras"; Rules, 1956.
2. In these Rules, unless the context otherwise requires—
 - " Commissioner " means the Commissioner of the District of Nicosia;
 - " Committee " means the Committee of the Irrigation Association;
 - " Irrigation Association " means the Irrigation Association of Philia "Dexameni tis Kannouras";
 - " Law " means the Irrigation (Private Water) Association Laws, 1949 and 1954;
 - " List " means the list of the names and residences of the proprietors and of the extent of the interest of each proprietor in the water, as finally settled in accordance with the provisions of section 11 of the Law;
 - " Works " means the irrigation works of the Irrigation Association,
