AMENDMENT OF ORDER MADE BY THE GOVERNOR UNDER DEFENCE  
REGULATION 64.

**THE DISEASES OF PLANTS (PREVENTION) LAW.  
CAP. 80.**

**ORDER UNDER SECTION 8.**

In exercise of the powers vested in him by section 8 of the Diseases of Plants (Prevention) Law, His Excellency the Governor has been pleased to order as follows:—

1. This Order may be cited as the Diseases of Plants (Prevention) (Restriction of Motor Vehicles Importation) Order, 1956.
2. As from the publication of this Order all motor vehicles (including military vehicles of all descriptions) which are landed at any port in Cyprus shall not be allowed to enter the Colony unless they are examined and found to be free from soil to the satisfaction of the Director of Agriculture or of his nominated representative.
3. If motor vehicles which are landed are found not to be free from soil, the Director of Agriculture or his nominated representative may require such vehicles to be washed to his satisfaction at the port of landing.
4. Fees as may be determined by the Director of Agriculture and exhibited at the port of landing for such washing and cleaning shall be paid by the person importing the motor vehicles.

**THE DISEASES OF PLANTS PREVENTION LAW.  
CAP. 80.**

**DECLARATION.**

In exercise of the powers vested in him by the Diseases of Plants Prevention Law, Cap. 80, His Excellency the Governor hereby declares the areas in the Schedule hereto to be infected with the plant disease, viz. with the insect known as *Ceratitis capitata*, Weid., the Mediterranean Fruit Fly.
