THE EMERGENCY POWERS ORDERS IN COUNCIL,
1939 AND 1956.

REGULATIONS MADE UNDER SECTION 6.

In exercise of the powers conferred on me by section 6 of the Emergency Powers Orders in Council, 1939 and 1956, I, the Governor, do hereby make the following regulations :—

1. These Regulations may be cited as the Emergency Powers (Amendment of the Estate Duty Law) (Amendment) Regulations, 1957, and shall be read as one with the Emergency Powers (Amendment of the Estate Duty Law) Regulations, 1956 (hereinafter referred to as "the principal Regulations") and the principal Regulations and these Regulations may together be cited as the Emergency Powers (Amendment of the Estate Duty Law) Regulations, 1956 and 1957.

2. The Schedule to the principal Regulations is hereby amended by—

(a) the numbering of the first paragraph in the second column thereto as " I ".

(b) the substitution for the words " sub-section (a) " in line 2 thereof of the words " sub-section (1) ".

(c) the numbering of the third paragraph in the Second Column thereto beginning with the words " Add the following new sub-section " as " II ".

(d) the addition of the following paragraph in the Second Column :—
" III. Substitute for the words ' five thousand pounds ' wherever they occur the words ' seven thousand and five hundred pounds '."

3. The above regulations shall be deemed to have come into force on the 22nd November, 1956.

No. 1080. THE BRITISH NATIONALITY ACT, 1948.

ORDER OF DEPRIVATION OF CITIZENSHIP UNDER SECTION 20.

Whereas Anastasia Panikou Adamou *alias* Anastasia Vambari of Piraeus, Greece, now of Limassol, a Greek subject purported to marry one Panayiotis Adamou a British subject on the 29th day of October, 1951 ;

And whereas the said Anastasia Panikou Adamou was on the 17th day of March, 1952, registered as a citizen of the United Kingdom and Colonies under sub-section (2) of section 6 of the British Nationality Act, 1948 ;

And whereas His Excellency the Governor, in exercise of the powers conferred upon him by sections 20 and 22 of the British Nationality Act, 1948, gave notice to the said Anastasia Panikou Adamou of his intention to make an order depriving her of citizenship of the United Kingdom and Colonies on the grounds set out in the said notice and informed her, in accordance with sub-section (6) of section 20 of the Act and Regulation 12 of the British Nationality Regulations, 1948, of her right to ask for an enquiry before the Order was made and gave her 21 days from the receipt of the said notice to ask for such enquiry ;

And whereas the said notice was served on the said Anastasia Panikou Adamou on the 12th August, 1957, and no request for an enquiry was made by her ;

And whereas His Excellency the Acting Governor is satisfied that the aforesaid registration was obtained by means of fraud, false representation and concealment of material facts by the said Anastasia Panikou Adamou :

Now, therefore, with the approval of the Secretary of State for the Colonies, I, George Evelyn Sinclair, Acting Governor, order that the said Anastasia Panikou Adamou *alias* Anastasia Vambari be and is hereby deprived of citizenship of the United Kingdom and Colonies.

THE BURIALS LAW.

CAP. 53 AND LAW 33 OF 1955.

ORDER MADE UNDER SECTION 15.

Whereas in pursuance of Notification No. 1178 published in Supplement No. 3 to the *Gazette* of the 29th November, 1956, a fit and proper site has been registered in the books of the Land Registry Office for use as a burial ground by the Moslem community of the village of Lapithiou, in the District of Paphos :

Now, therefore, in exercise of the powers vested in the Governor by section 15 of the Burials Law, and duly delegated to me under Notification No. 172, published in Supplement No. 3 to the *Gazette* of the 19th June, 1947, I do hereby order that from and after the 13th December, 1957, no burial shall take place in the burial ground in lieu whereof the new burial ground above referred to has been provided.
