THE EMERGENCY POWERS (CONTROL OF BUILDING OPERATIONS) (No. 2) REGULATIONS, 1956.

NOTIFICATION UNDER REGULATION 7.

In exercise of the powers vested in him by Regulation 7 of the Emergency Powers (Control of Building Operations) (No. 2) Regulations, 1956, His Excellency the Governor has been pleased to exempt the following building from the provisions of the said Regulations:—

A block of latrines to be erected by the Town Committee of Moslem Elementary Schools of Famagusta, in the yard of the Turkish Elementary School situate on Plot 259 of the Government Survey Plan No. XXXIII, 4.5.III and IV, in the old town of Famagusta.

No. 126. THE EXCHANGE CONTROL LAWS, 1952 AND 1954.

ORDER MADE BY THE FINANCIAL SECRETARY UNDER SECTIONS 7, 25 AND 33.

In exercise of the powers vested in me by sections 7, 25 and 33 of the Exchange Control Laws, 1952 and 1954, I, the Financial Secretary, hereby order as follows:—

1. This Order may be cited as the Exchange Control (Payments) Amendment Order, 1957, and shall be read as one with the Exchange Control (Payments) Orders, 1954 to 1956 (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Exchange Control (Payments) Orders, 1954 to 1957.

2. The principal Order is hereby amended by inserting before item 1 thereof in the first column the word and figures "or Austria" and in the second column—

(a) Payment in sterling from a Transferable Account of a person resident in a Transferable Account territory.

(b) Payment in sterling from an account of a person resident in any territory specified in the First Schedule to this Order.

(c) Payment in Austrian schillings."

3. This Order shall be deemed to have been made and to have come into force on the second day of January, 1957.

THE EXCHANGE CONTROL LAWS, 1952 AND 1954.

ORDER MADE BY THE FINANCIAL SECRETARY UNDER SECTION 4.

In exercise of the powers vested in me by section 4 of the Exchange Control Laws, 1952 and 1954 (hereinafter referred to as "the Law"), I, the Financial Secretary, hereby order as follows:—

1. This Order may be cited as the Exchange Control (Specified Currency) Order, 1957.

2. The Exchange Control (Specified Currency) Orders, 1954 and 1955, are hereby revoked.

3. The foreign currency set out in the Schedule to this Order is hereby specified as foreign currency to which section 4 of the Law, applies.

4. This Order shall be deemed to have been made and to have come into force on the 2nd day of January, 1957.
