THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CYPRUS) ORDER, 1946.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

In exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force in consequence of the Supplies and Services (Continuance) Order, 1956), His Excellency the Governor by this Order, orders as follows:—

1. Subject to the restrictions and conditions contained in the First Schedule to this Order, the use, for military purposes, of the land and property specified in the Second Schedule (hereinafter referred to as "the land") during the period of six months commencing on the 5th March, 1957, and ending on the 4th September, 1957.

2. The persons using the land in pursuance of this Order are entitled to do thereon or in relation thereto such acts as may be necessary for such military purposes.

3. The exercise of any right of way over the land and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited during the period this Order shall remain in force.

FIRST SCHEDULE.

1. The land shall be occupied and used for military purposes only.
2. At the expiration of this Order the land shall be restored to the persons entitled thereto free of any erection, structure or construction erected or constructed thereon after the making of the Order.

3. Compensation shall be paid to the persons having an interest on the land for its use and occupation under this Order.

SECOND SCHEDULE.

All the privately owned land situated in Pyroi and Potamia Villages, Nicosia District, that is to say:—

- (a) The land under Plot Nos. 143, 144 and part of Plot Nos. 139, 13, 43, 16, 14, 189/2, 236, 56, 57, 58, 60, 44, 190, 191, 188, 186 and 180 shown on the Government Survey Plans Sheets XXXI.34 and XXXI.35; Part of Plot Nos. 190, 188, 187, 180, 179 and 172 shown on the Government Survey Plans Sheets XXXI.34 and XXXI.42 all which said areas are more particularly defined as the area coloured red on the plan signed by the Assistant Director of Hirings, Cyprus, dated 4th March, 1957, a copy of which is deposited in the Commissioner's Office, Nicosia.
- (b) The wayleave for a water pipeline on Part of Plot Nos. 3, 4, 20, 23, 22, 169, 170, 171, 172, 164, 175, 185/2, 185/1, 189/1, 190, 236, 189/2, 139, 140, 13, 191, 188, 190, 189, 188, 187, 180, 172, 173, 179, shown on the Government Survey Plans Sheets XXXI.34, XXXI.35 and XXXI.42, all which said wayleaves are more particularly defined as the area coloured blue on the plan signed by the Assistant Director of Hirings, Cyprus, dated 4th March, 1957, a copy of which is deposited in the Commissioner's Office, Nicosia.

THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.

REVOCATION OF ORDER MADE BY THE GOVERNOR UNDER
DEFENCE REGULATION 64.

In exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force in consequence of the Supplies and Services (Continuance) Order, 1956), His Excellency the Governor hereby revokes the Order made by him under Defence Regulation 64 and published under Notification No. 1223 in Supplement No. 3 to the *Gazette* of the 13th December, 1956, without prejudice to anything done or left undone thereunder.
