CAP. 1.**

**DELEGATION OF AUTHORITY UNDER SECTION 21.**

I, the Governor, in exercise of the powers conferred by section 21 of Cap. 1. the Interpretation Law, do hereby depute the persons for the time being holding the office designated in the third column of the Schedule hereto to exercise and perform on my behalf the powers and duties set out in the second column of the said Schedule which I am empowered to exercise or perform under the provisions of the Laws set out in the first column thereof and Notification 172 published in Supplement No. 3 to *Gazette* No. 3311 of the 19th June, 1947, is hereby amended as follows:—

(i) by the deletion of Item Nos. 9, 18, 25 and 27 (b) of the said Schedule and the substitution therefor of the following items:—

To direct rewards to be paid to any person who shall have given information which led to the apprehension of any offender under this Law or to the discovery or seizure of any goods in respect of which there is reason to believe that an offence under this Law has been committed.	9.—(a) Comptroller of Customs and Excise.
(b) The Customs Management Laws, 1954 and 1955, Section 236.	To order to be paid, in respect of any Customs offences or seizures or smuggled, prohibited, restricted or regulated goods made under the Customs Laws, to the person or persons making the seizure or giving information which led to the conviction of the offender, such reward as he may see fit.	(b) Comptroller of Customs and Excise.

(c) The Customs Management Laws, 1954 and 1955, Section 237.	To award to any officer or other person detaining any person liable to detention under any Customs Law, if such person shall be convicted, such reward as he may think fit, not exceeding the sum of twenty-five pounds for each person so detained.	(c) Comptroller of Customs and Excise.
18. Matches (Excise Duty) Law, Cap. 298 Section 11.	To offer a reward not exceeding one-half of any fine or pecuniary composition to any officer or any other person by whose means the same is recovered.	18. Comptroller of Customs and Excise.
25. Salt Law, Cap. 153, Section 12.	To award to any person who shall have given information which led to the apprehension of the offender a reward not exceeding one-half of the fine imposed by the Court before which an offence under this Law is tried or the penalty recovered under the provisions of section 11 of the Law.	25. Comptroller of Customs and Excise.
27.—(b) Tobacco Law, Cap. 170, Section 66.	To direct that such reward as he may think fit may be paid to any person who shall have given information which led to the apprehension of any offender under this Law, or to the discovery or seizure of any goods in respect of which there is reason to believe that an offence under this Law has been committed.	27.—(b) Comptroller of Customs and Excise.

32. Playing Cards Excise Law, Cap. 299, Section 10.	To grant a reward not exceeding one-half out of any fine or pecuniary payment to any person by whose means the same is recovered.	32. Comptroller of Customs and Excise.

To order to be paid, in respect of the detection of any offence under this Law, or any regulations made thereunder, to the person or persons making the seizure or giving the information which led to the detection such a reward as he may think fit.	33. Comptroller of Customs and Excise.
34. Intoxicating Liquor (Manufacture) Licensing Laws, 1950 to 1954, Section 39.	To order to be paid, in respect of the detection of any offence under this Law, or any regulations made thereunder, to the person or persons making the seizure or giving the information which led to the detection, such reward as he may think fit.	34. Comptroller of Customs and Excise.
