Whereas by Order dated the 23rd October, 1955, and published in Supplement No. 3 to the *Gazette* of the 24th October, 1955, under Notification No. 652 (hereinafter referred to as "the Order") His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated in the village of Eylenja (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;
