In exercise of the powers vested in him by section 232 of the Customs Management Laws, 1954 and 1955, His Excellency the Governor, with the advice of the Executive Council, has been pleased to make the following regulations :—

These regulations may be cited as the Customs Drawback (Amendment) Regulations, 1957, and shall be read as one with the Customs Drawback Regulations, 1956 and the Customs Drawback (Amendment) Regulations, 1956 (hereinafter referred to as the "principal Regulations"), and these Regulations and the principal Regulations may together be cited as the Customs Drawback Regulations, 1956 to 1957.

**No. 455.****THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 3) 1957.****ORDER MADE UNDER REGULATION 44.**

Whereas it appears to me to be expedient in the interest of public order and safety to take possession of the land described in the Schedule hereto (hereinafter referred to as "the land") and to authorize its use in the interest of public order and safety :

Now, therefore, in exercise of the powers vested in the Governor by regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1957, which I have been authorized to exercise under Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I, the Commissioner of Nicosia and Kyrenia, have taken possession of the land with effect from 1st September, 1956, and in connection with the taking possession and making use of the land, I hereby direct and order as follows :—

- (1) The use of the land for the requirements of Her Majesty's Forces is hereby authorized.
- (2) The persons using the land in pursuance of this Order are hereby authorized to do, in relation to the land anything which any person having an interest in the land would be entitled to do by virtue of that interest.
- (3) The exercise of any right of way over the land, and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited.

## SCHEDULE.

All that privately owned land situated at Pano and Kato Lakatamia village, Nicosia District, that is to say :—

The land under part of plots 35, 37, 38, 39 and 36 Block F at Pano Lakatamia and part of plots 201 and 244 Block E at Kato Lakatamia of the Government Survey Plan Sheet XXX.21.W.2, more particularly defined as the area coloured red on the plan signed by the Assistant Director of Hirings, Cyprus, and dated 30th March, 1957, a copy of which is deposited in the office of the Commissioner, Nicosia and Kyrenia.

THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 3) 1957.

ORDER MADE UNDER REGULATION 44.

Whereas it appears to me to be expedient in the interest of public order and safety to take possession of the land described in the Schedule hereto (hereinafter referred to as "the land") and to authorize its use in the interest of public order and safety :

Now, therefore, in exercise of the powers vested in the Governor by regulation 44 of the Emergency Powers (Public Order and Safety) Regulations, 1955 to (No. 3) 1957, which I have been authorized to exercise under Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I, the Commissioner of Nicosia and Kyrenia, hereby take possession of the land and in connection with the taking possession and making use of the land, I hereby direct and order as follows :—

- (1) The use of the land for the requirements of Her Majesty's Forces is hereby authorized.
- (2) The persons using the land in pursuance of this Order are hereby authorized to do, in relation to the land anything which any person having an interest in the land would be entitled to do by virtue of that interest.
- (3) The exercise of any right of way over the land, and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited.

SCHEDULE.

All that area of privately owned land situated at Kyrenia, that is to say :—

The land under plot Nos. 81/11/1, 2, 3, 4, 5, 6, 8, 9, 10, 11 of the Government Survey Plan Sheet XII/21, 1, VI & V2 more particularly defined as the area coloured red on the plan kept in the Commissioner's office of Nicosia.
