**No. 510. THE LAND ACQUISITION LAW.**

CAP. 233 AND LAWS 26 OF 1952 AND 22 OF 1956.

NOTICE UNDER SECTION 7.

Whereas by Notification published under No. 1035 in Supplement No. 3 to the *Gazette* of the 25th November, 1956, the Governor declared under sections 2, 3 and 5 of the Land Acquisition Law the establishment of a Poultry Unit in the vicinity of Perivolia-tou-Trikomou, Famagusta District, to be an undertaking of public utility;

And whereas the Commissioner of Famagusta by a notice published under Notification No. 200 in Supplement No. 3 to the *Gazette* of the 21st February, 1957, gave particulars of the properties (hereinafter referred to as "the properties") required in connection with the aforesaid undertaking;

And whereas the Commissioner of Famagusta forwarded to the Governor the required recommendations, plans and particulars together with a report that no objections have been made;

And whereas the Governor has approved the plan and particulars submitted, and has considered it expedient, having regard to the circumstances of the case, that the properties be acquired:

Now, therefore, in exercise of the powers vested in him by section 7 of the Land Acquisition Law, the Governor hereby sanctions the acquisition of the properties under the provisions of the said Law.

**No. 511. THE LAND ACQUISITION LAW.**

CAP. 233 AND LAWS 26 OF 1952, 43 OF 1955 AND 22 OF 1956.

**NOTIFICATION UNDER SECTION 7.**

Whereas by Notification No. 904 published in Supplement No. 3 to the *Gazette* of the 20th September, 1956, the Governor declared the widening, improving and realigning of the public road between Nicosia and the junction to Larnaca on the Nicosia-Famagusta Road (known as Kalopsidha Junction) to be an undertaking of public utility;

And whereas the Commissioner of Famagusta in compliance with section 6 of the Land Acquisition Law, by a notice published under Notification No. 199 in Supplement No. 3 to the *Gazette* of the 21st February, 1957, gave particulars of the lands required in connection with the aforesaid undertaking (hereinafter referred to as "the lands");

And whereas the Commissioner of Famagusta forwarded to the Governor the required recommendations, plans and particulars, together with the objections made;

And whereas, having considered the objections made thereto the Governor has approved the plans and particulars submitted, and has considered it expedient, having regard to the circumstances of the case, that the lands be acquired:

Now, therefore, in exercise of the powers vested in him by section 7 of the Land Acquisition Law, the Governor hereby sanctions the acquisition of the lands under the provisions of the said Law.
