**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 3) 1957.**

ORDER MADE UNDER REGULATION 38.

In exercise of the powers vested in me by Regulation 38 (1) of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1957, I, Warren Frederick Martin Clemens, Commissioner of Nicosia and Kyrenia, do hereby order as follows:—

1. This Order may be cited as the Protected Areas (Nicosia District) Order, 1957.

2. The area specified in the Schedule hereto is hereby declared to be a protected area for the purposes of Regulation 38 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1957, with effect from 18th April, 1957, until further Order.

SCHEDULE.

Place	Limits
Makheras Monastery . .	All the premises known as Makheras Monastery and all the area falling within a radius of 200 yards from the outer walls of the main building.

**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 3) 1957.**

ORDER MADE UNDER REGULATION 44.

Whereas it appears to me to be expedient in the interest of public order and safety to take possession of the land described in the Schedule hereto (hereinafter referred to as "the land") and to authorize its use in the interest of public order and safety:

Now, therefore, in exercise of the powers vested in the Governor by regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1957, which I have been authorized to exercise under Notification No. 736 published in Supplement No. 3 to the *Gazette* of the 26th November, 1955, I, the Commissioner of Paphos, have taken possession of the land with effect from 1st September, 1956, and in connection with the taking possession and making use of the land, I hereby direct and order as follows:—

- (1) The use of the land for the requirements of Her Majesty's Forces is hereby authorized.
- (2) The persons using the land in pursuance of this Order are hereby authorized to do, in relation to the land anything which any person having an interest in the land would be entitled to do by virtue of that interest.

- (3) The exercise of any right of way over the land, and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited.

SCHEDULE.

All that area of privately owned land at Pomos village, Paphos District, being plot Nos. 34 and 35 on the Government Survey Plan XLVII/63 and 62 and more particularly defined as the area coloured in red on the plan signed by the Commissioner of Paphos and dated 23rd April, 1957, a copy of which is available at the Office of the Commissioner of Paphos.
