NOTICE UNDER SECTION 17 (7).

With reference to the notice published under No. 1367 in the *Gazette* of 8th December, 1955, as amended by notice No. 1213 published in the *Gazette* of 25th October, 1956, it is hereby notified for general information that, after considering the plans and specifications concerning the street shown under column (1) of the Schedule hereto and objections made, the Governor, with the advice of the Executive Council, has been pleased to approve the plans and specifications concerning the said street to the extent shown under column (2) of the Schedule hereto.

2. The plans and specifications in respect of the said street shall, subject to the condition shown under column (2) of the Schedule, be binding on the Municipal Council of Nicosia and upon all owners affected.
