## NOTIFICATION UNDER SECTION 7.

Whereas by Notification published under No. 154 in Supplement No. 3 to the *Gazette* of the 1st March, 1956, the Governor declared the building of residential quarters for members of the Cyprus Police Force to be an undertaking of public utility :

And whereas the Commissioner of Paphos, by notice published under No. 588 in Supplement No. 3 to the *Gazette* of the 6th June, 1957, gave particulars of the land required in connection with the aforesaid undertaking of public utility (hereinafter referred to as "the land") ;

And whereas the Commissioner of Paphos forwarded to the Governor's Deputy the required recommendations, plan and particulars in connection with the land, no objections to the proposed acquisition having been made ;

And whereas the Governor's Deputy has approved the plan and particulars submitted and has considered it expedient, having regard to all the circumstances of the case, that the land be acquired :

Now, therefore, in exercise of the powers vested in him by section 7 of the Land Acquisition Law, the Governor's Deputy has been pleased to sanction the acquisition, under the provisions of the said Law, of the land.

## THE LAND ACQUISITION LAW.

## NOTICE UNDER SECTION 19 (1).

Whereas by Notification No. 665 published in Supplement No. 3 to the *Gazette* of the 25th November, 1954, His Excellency the Governor declared the carrying out of extensions and improvements of the Famagusta Port to be an undertaking of public utility ;

And whereas by Notification No. 1119 published in Supplement No. 3 to the *Gazette* of the 22nd November, 1956, His Excellency the Governor sanctioned the acquisition of the lands referred to in the said Notification (hereinafter referred to as "the acquired land"), for the purposes of the said undertaking ;

And whereas a portion of the acquired land, the particulars whereof are set out in the Schedule hereto, is no longer required for the purpose for which it was acquired ;

And whereas His Excellency the Governor by Notification No. 89 published in Supplement No. 3 to the *Gazette* of the 11th February, 1954, declared the acquisition of certain lands situated near the Northern Glacis of the Fortifications of the Old Famagusta Town to be an undertaking of public utility ;

And whereas a portion of the acquired land, the particulars whereof are set out in the Schedule hereto, is included in the lands situated near the Northern Glacis of the Fortifications of the Old Famagusta Town, the acquisition of which has been declared to be an undertaking of public

utility, in respect of which the above mentioned Notification has been published in the *Gazette* under the provisions of the Land Acquisition Law :

Now, therefore, it is hereby notified that the land, the particulars whereof are set out in the Schedule hereto will, under the provisions of sub-section (1) of section 19 of the Land Acquisition Law, be retained for the purposes of the Northern Glacis of the Fortifications of the Old Famagusta Town.

SCHEDULE.

An area of land situated at Ayios Loukas Quarter, Famagusta Town, comprising 14 donums and 3 evleks or thereabouts and including parts of plots Nos. 53, 54 and 701 and the whole of plot No. 353 of Block C, more particularly defined as the area coloured red on the plan signed by the Acting Director of Lands and Surveys, dated the 25th June, 1957, and deposited in the office of the Commissioner, Famagusta.

**No. 751. THE CURFEWS LAWS, 1955.**  
LAWS 17 AND 47 OF 1955.

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of the 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Nicosia District No. 22) Order, 1957.

2. No person within the area prescribed in the First Schedule hereto shall be out of doors between the hours prescribed in the Second Schedule hereto except under the authority of a written permit granted by the Commissioner of Nicosia or the Assistant Chief Constable in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, or the Cyprus Police Force.

This Order shall come into force on the 24th day of July, 1957.
