THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.

AMENDMENT OF ORDER MADE BY THE GOVERNOR UNDER DEFENCE
REGULATION 64.

In exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force in consequence of the Supplies and Services (Continuance) Order, 1956), His Excellency the Governor hereby amends the Order made by him under Defence Regulation 64 and published under Notification No. 468 in Supplement No. 3 to the *Gazette* of the 7th June, 1956 (as extended by Notification Nos. 1165 and 400 in Supplement No. 3 to the *Gazettes* of the 29th November, 1956 and 11th April, 1957 respectively) by deleting the Second Schedule thereto and substituting therefor of the following Second Schedule :—

“ SECOND SCHEDULE.

All the privately owned property known as the “ COEUR-DE-LION HOTEL ”, with all buildings erected thereon and appurtenances thereto, under plots Nos. 5 and 10/1 of the Government Survey Plan of Kato Kyrenia, more particularly defined as the area coloured red on the plan signed by the Assistant Director of Hirings, Cyprus, dated the 26th July, 1957, and deposited in the Commissioner's Office, Kyrenia ”.

THE LAND ACQUISITION LAW.

CAP. 233 AND LAWS 26 OF 1952, 43 OF 1955 AND 22 OF 1956.

NOTIFICATION UNDER SECTION 7.

Whereas by Notification published under No. 154 in Supplement No. 3 to the *Gazette* of the 1st March, 1956, the Governor declared the building of residential quarters for members of the Cyprus Police Force to be an undertaking of public utility ;

And whereas the Commissioner of Famagusta, by notice published under No. 800 in Supplement No. 3 to the *Gazette* of the 22nd August, 1957, gave particulars of the land required in connection with the aforesaid undertaking of public utility (hereinafter referred to as “ the land ”) ;

And whereas the Commissioner of Famagusta forwarded to the Governor the required recommendations, plan and particulars in connection with the land, no objections to the proposed acquisition having been made ;

And whereas the Governor has approved the plan and particulars submitted and has considered it expedient, having regard to all the circumstances of the case, that the land be acquired :

Now, therefore, in exercise of the powers vested in him by section 7 of the Land Acquisition Law, the Governor has been pleased to sanction the acquisition, under the provisions of the said Law, of the land.

NOTICE UNDER SECTION 6.

With reference to Notification No. 154 published in Supplement No. 3 to the *Gazette* of the 1st March, 1956, notice is hereby given that the following lands are required for the undertaking of public utility mentioned therein :—

All that privately owned land situated at Myrtou village, under plots Nos. 359, 396/1, 396/2, 396/3 and 396/4 of the Government Survey Plan No. XI.27, more particularly defined as the area coloured red on the plan signed by the Commissioner, Nicosia and Kyrenia, dated the 4th September, 1957, and deposited in his office at Kyrenia.

2. Any person claiming to have any right or interest in the said lands who objects to the acquisition, is required within ten days from the date of the publication of this notice to send to me a statement of his right and interest and of the evidence thereof and of any claim made by him in respect of such right or interest.

3. The Government is willing to treat for the acquisition of the said lands.

4. A plan showing the lands described above is available for inspection at my office in Kyrenia.

5. The period mentioned in paragraph 2 hereof has been abridged to ten days with the approval of His Excellency the Governor.
