

27. The danger signals to be hoisted in respect of the Polemidhia Bombardment Range Area shall be as follows :—

(a) By Day :

- (i) A red flag hoisted on the road WEST of the stop butts.
- (ii) A red flag hoisted at the highest point of the hill directly NORTH of the stop butts.
- (iii) A red flag hoisted on the highest point of the hill on the EAST of the range.

(b) By Night :

Red lamps hoisted on flag poles situated as in (a) (i), (ii) and (iii) above.

THE PYLA BOMBARDMENT RANGE AREA.

28. In this part of these regulations the "Pyla Bombardment Range Area" means the area declared as such under section 2 of the Law by notice published in Supplement No. 3 to the *Gazette* of the 30th May, 1957, or by any other notice amending or substituted for the same.

29. The danger signals to be hoisted or displayed in respect of the Pyla Bombardment Range Area shall be as follows :—

(a) By Day :

- (i) A red flag on Cape Greco.
- (ii) A red flag on Cape Pyla.
- (iii) A red flag at Dhekalia.
- (iv) A red flag displayed from a boat patrolling outside the limits of the sea Danger Area.

(b) By Night :

A red light displayed at each of the four points mentioned in subparagraphs (i), (ii), (iii) and (iv) of paragraph (a) above.

30. The Bombardment Range Areas Regulations, 1949 to 1956, are hereby revoked without prejudice to anything done or left undone thereunder.

THE EXCHANGE CONTROL LAWS, 1952 AND 1954.

ORDER MADE BY THE FINANCIAL SECRETARY UNDER SECTION 2 (1).

In exercise of the powers vested in me by section 2 (1) of the Exchange Control Laws, 1952 and 1954 (hereinafter referred to as "the Law"), I, the Financial Secretary, hereby order as follows :—

1. This Order may be cited as the Exchange Control (Authorised Dealers) Order, 1957.

2. The persons specified in the First Schedule hereto are hereby authorised to act for the purposes of the Law as authorised dealers in relation to gold and foreign currency.

3. The persons specified in the Second Schedule hereto are hereby authorised to act for the purposes of the Law as authorised dealers in relation to gold only.
