

No. 1033. THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955 TO (No. 5) 1958.

ORDER UNDER REGULATION 34.

In exercise of the powers vested in me by paragraph (b) of Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 5) 1958, I, the Commissioner of Paphos, do hereby make the following Order :—

1. This Order may be cited as the Paphos District (Control of Vehicular Traffic) (No. 6) Order, 1958.

2. The use or circulation of any vehicle within the area set out in the Schedule hereto is hereby prohibited from 0300 hours on Tuesday, 18th November, 1958, until further notice, except under the authority of a written permit granted by me or by the Officer in charge of Paphos Police Division :

Provided that this paragraph shall not apply to :—

- (a) members of Her Majesty's Forces ;
- (b) members of the Cyprus Police Force (as defined in the Police Law) when on duty as such.

3. This Order shall come into force on the 18th November, 1958.

THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955 TO (No. 5) 1958.

ORDER UNDER REGULATION 34.

In exercise of the powers vested in me by paragraph (b) of Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, I, the Commissioner of Larnaca, do hereby make the following Order :—

1. This Order may be cited as the Larnaca District (Control of Bicycles, Motor Cycles and Scooters) (No. 2) Order, 1958.

2. The use or circulation of any bicycle, motor cycle, and scooter on any road within the area set out in the Schedule hereto is hereby prohibited except under the authority of a written permit granted by me or by the officer in charge of Larnaca Police Division :

Provided that this paragraph shall not apply to :—

- (a) Members of Her Majesty's Forces.
- (b) Members of the Cyprus Police Force (as defined in the Police Law) when on duty as such.
- (c) Persons who can prove that they were born before 1st August, 1931.
- (d) All female persons.

3. No bicycle, motor cycle, or scooter, shall be left in any road or any place to which the public have access in the area specified in the Schedule hereto.

4. This Order shall come into force from 0500 hours on the 9th November, 1958, until further notice.

5. The Larnaca District (Control of Bicycles) (No. 1) Order, 1958, is hereby revoked.

THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955 TO (No. 5) 1958.

ORDER UNDER REGULATION 34.

In exercise of the powers vested in me by paragraph (b) of Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955, to (No. 5) 1958, I, the Assistant Commissioner of Kyrenia, do hereby make the following Order:—

1. This Order may be cited as the Kyrenia District (Control of Motor Cycles and Bicycles) (No. 2) Order, 1958.

2. The use or circulation of any motor cycle or bicycle on any road within the area set out in the Schedule hereto is hereby prohibited except under the authority of a written permit granted by me or by the officer in charge of Kyrenia Police Division:

Provided that this paragraph shall not apply to—

(a) Members of Her Majesty's Forces.

(b) Members of the Cyprus Police Force (as defined in the Police Law) when on duty as such.

(c) Persons born before the 1st August, 1931.

(d) All female persons.

3. No person born after the 1st August, 1931, shall ride a motor cycle or bicycle as a pillion rider.

4. No motor cycle or bicycle shall be left in any road or any place to which the public have access in the area specified in the Schedule hereto.

5. The Control of Bicycles (Kyrenia District) (No. 1) Order, 1958, is hereby revoked.

6. This Order shall come into force on 9th November, 1958.
