**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 6) 1958.**

**ORDER MADE UNDER REGULATION 34.**

In exercise of the powers vested in me under paragraph (b) of Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 6) 1958, I, the Commissioner of Limassol, do hereby make the following Order :—

1. This Order may be cited as the (Limassol District) (Control of Bicycles and Motor Cycles) (No. 3) Order, 1958.

2. The use or circulation of any bicycle or motor cycle on any road within the area set out in the First Schedule hereto is hereby prohibited between the hours prescribed in the Second Schedule hereto, except under the authority of a written permit granted by me or by the Assistant Chief Constable in charge of the area :

Provided that this paragraph shall not apply to—

- (a) members of Her Majesty's Forces ;
- (b) members of the Cyprus Police Force (as defined in the Police Law) when on duty as such ;
- (c) persons who can prove that they are over the age of 27 years ;
- (d) persons who are not members of the Greek Cypriot community.

3. No bicycle or motor cycle shall be left in any road or any place to which the public have access in the area specified in the First Schedule hereto.

4. This Order shall come into force on the 19th day of November, 1958, and shall remain in force until further notice.

Within the village boundaries of Kolossi and Erimi.

**SECOND SCHEDULE.**

From 1700 hours until 0600 hours.

**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)  
REGULATIONS, 1955 TO (No. 5) 1958.**

**ORDER UNDER REGULATION 34.**

In exercise of the powers vested in me by paragraph (b) of Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 5) 1958, I, the Commissioner of Famagusta, do hereby make the following Order :—

1. This Order may be cited as the (Famagusta District) (Control of Bicycles) (No. 3) Order, 1958, and shall come into force on the 9th day of November, 1958.

2. The use or circulation of any bicycle, motor cycle, or motor scooter by any person, male or female, within the area set out in the Schedule

hereto is hereby prohibited except under the authority of a written permit granted by me or by the Officer in charge of Famagusta Police Division :

Provided that this paragraph shall not apply to—

- (a) members of Her Majesty's Forces ;
- (b) members of the Cyprus Police Force (as defined in the Police Law) when on duty as such ;
- (c) persons who can prove that they are under the age of ten years or over the age of twenty-seven years.

3. No bicycle, motor cycle, or motor scooter shall be left in any road or any place to which the public have access in the area specified in the Schedule hereto.

4. The Famagusta District (Control of Bicycles) (No. 2) Order, 1958, is hereby revoked.

**THE EMERGENCY POWERS (PUBLIC SAFETY) AND ORDER REGULATIONS, 1955 TO (No. 5) 1958.**

ORDER UNDER REGULATION 34.

In exercise of the powers vested in me by paragraph (b) of Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 5) 1958, I, the Commissioner of Paphos, do hereby make the following Order :—

1. This Order may be cited as the Control of Bicycles and Motor Cycles (Paphos District) (No. 3) Order, 1958.

2. The use or circulation of any bicycle, motor cycle or motor scooter on any road within the area set out in the Schedule hereto is hereby prohibited except under the authority of a written permit granted by me or by the Officer in charge of Paphos Police Division :

Provided that this paragraph shall not apply to—

- (a) members of Her Majesty's Forces ;
- (b) members of the Cyprus Police Force (as defined in the Police Law) when on duty as such ;
- (c) persons who are not members of the Greek Cypriot community ;
- (d) members of the Greek Cypriot community who can prove that they were born before the 1st day of August, 1931, or after the 31st day of July, 1948.

3. No bicycle, motor cycle or motor scooter shall be left in any road or any place to which the public have access in the area specified in the Schedule hereto.

4. This Order shall come into force at 0430 hours on the 20th day of November, 1958.

5. The Control of Bicycles (Paphos District) (No. 2) Order, 1958, and the Paphos District (Control of Motor Cycles) (No. 1) Order, 1958, is hereby revoked.

Within the Town and Village boundaries of Ktima and Kato Paphos.
