**No. 139. THE LAND ACQUISITION LAW.**

CAP. 233 AND LAWS 26 OF 1952, 43 OF 1955 AND 22 OF 1956.

NOTICE UNDER SECTION 7.

Whereas by Notification published under No. 812 in Supplement No. 3 to the *Gazette* of the 29th August, 1957, the Governor declared under sections 2, 3 and 5 of the Land Acquisition Law the erection of an Orta Okul at Kyrenia and any other erections or structures as are from time to time considered to be necessary in connection with the school to be an undertaking of public utility ;

And whereas the Commissioner of Nicosia and Kyrenia by a Notice published under Notification No. 989 in Supplement No. 3 to the *Gazette* of the 7th November, 1957, gave particulars of the property (hereinafter referred to as “ the properties ”) required in connection with the aforesaid undertaking ;

And whereas the Commissioner of Nicosia and Kyrenia forwarded to the Governor the required recommendations, plans and particulars, together with the objection made ;

And whereas the Governor has approved the plan and particulars submitted and has considered it expedient, having regard to the circumstances of the case, that the properties be acquired, with the exception of plot No. 216/5 of the Government Survey Plan No. XII.21 :

Now, therefore, in exercise of the powers vested in him by section 7 of the Land Acquisition Law, the Governor hereby sanctions the acquisition of the properties under the provisions of the said Law, with the exception of the aforesaid plot No. 216/5.

**THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)  
(CYPRUS) ORDER, 1946.**

**ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.**

Whereas by Order dated the 5th October, 1956, and published in Supplement No. 3 to the *Gazette* of the 11th October, 1956, under Notification No. 965 (hereinafter referred to as "the Order") His Excellency the Governor has authorized the use for military purposes of the land and property set out in the Second Schedule to the Order, situated in the village of Eylenja (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Notifications Nos. 398 and 888 published in Supplement No. 3 to the *Gazettes* of the 11th April, 1957, and 26th September, 1957, respectively, the Order was extended for further periods of six months up to the 8th April, 1958 ;

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :

Now, therefore, in exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force by virtue of the Supplies and Services (Continuance) Order, 1957), His Excellency the Governor has been pleased to order and hereby orders that the aforesaid authorization for using the land for military purposes subject to the restrictions and conditions laid down in the Order be continued for a further period of six months as from the 5th April, 1958, and the Order is so extended accordingly.
