Whereas by Order dated the 12th March, 1956, and published in Supplement No. 3 to the *Gazette* of the 15th March, 1956, under Notification No. 178 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated in the village of Yialousa (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Notifications Nos. 969, 219 and 819 published in Supplement No. 3 to the *Gazettes* of the 11th October, 1956, 28th February, 1957 and 29th August, 1957, respectively, the Order was extended for further periods of six months up to the 11th March, 1958 ;
