**THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.**

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 3rd September, 1956, and published in Supplement No. 3 to the *Gazette* of the 6th September, 1956, under Notification No. 850 (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated at Eylenja village (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Notifications Nos. 220 and 814 published in Supplement No. 3 to the *Gazettes* of the 28th February, 1957 and 29th August, 1957, respectively, the Order was extended for further periods of six months up to the 2nd March, 1958 ;

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 16th September, 1955, and published in Supplement No. 3 to the *Gazette* of the 17th September, 1955, under Notification No. 546 (as amended by Notification No. 92 published in Supplement No. 3 to the *Gazette* of the 9th February, 1956) (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated at Kato Polemidhia and Chiftikler Quarter, Limassol (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;
