NOTICE UNDER SECTION 6.

With reference to notification No. 1036 published in Supplement No. 3 to the *Gazette* of the 1st November, 1956, notice is hereby given that the following lands are required for the undertaking of public utility mentioned therein:—

All those areas of privately owned lands, with everything standing thereon, situated at Larnaca Town, comprising 7 donums or thereabouts, forming parts of plots Nos. 36, 106, 109, 39, 40 and 29 of Block L and more particularly defined as the area coloured red on the plan signed by the Director of Public Works and dated the 15th February, 1958.

2. Any person claiming to have any right or interest in the said lands, who objects to the acquisition, is required within six weeks from the date of the publication of this notice to send to me a statement of his right and interest and of the evidence thereof and of any claim made by him in respect of such right or interest.

3. The Government is willing to treat for the acquisition of the said lands.
