THE EMERGENCY POWERS ORDERS IN COUNCIL,
1939 AND 1956.

REGULATIONS MADE UNDER SECTION 6.

In exercise of the powers conferred on me by section 6 of the Emergency Powers Orders in Council, 1939 and 1956, I, the Governor, do hereby make the following regulations :—

1. These Regulations may be cited as the Emergency Powers (Amendment of the Villages (Administration and Improvement) Laws) Regulations, 1958.

2. In these Regulations—

 31 of 1953.

“ Law ” means the Villages (Administration and Improvement) Laws, 1950 to 1953 ;

“ specified purpose ” means a purpose under the Law which the Commissioner has, under his hand, specified for the purposes of these Regulations.

3. Section 6 of the Law is hereby amended by the addition thereto of the following sub-section at the end of sub-section (6) thereof :—

“(7) Notwithstanding the provisions of sub-sections (1) to (6) of this section an Improvement Area Board shall be deemed to be duly constituted and shall function through its nominated members, either for a specified purpose or all of the purposes of the Law, irrespective of the absence or resignation of the elected members or any of them therefrom.”

In exercise of the powers vested in him by section 3 (2) of the Forest Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows :—

1. This Order may be cited as the Minor State Forests (Famagusta) (Amendment) Order, 1958, and shall be read as one with the Minor State Forests (Famagusta) Orders, 1943 to 1955 (hereinafter referred to as “ the principal Order ”) and the principal Order and this Order may together be cited as the Minor State Forests (Famagusta) Orders, 1943 to 1958.

2. The Schedule to the principal Order is hereby amended as follows :—

(a) By the addition to area No. 20 (relating to the village of Yenagra) of the following area :—

The Crown lands under plots Nos. 141/2 and 141/3 of Sheet No. XXIII, Plan No. 19, at the locality “ Petrelar ” formerly part of the Cyprus Government Railway land, demarcated by boundary stones numbered consecutively from 1-8 inclusive, comprising 9 donums, 1 evlek and 1000 square feet or thereabouts and shown on the Government Survey Plan Serial No. 1697, delineated thereon in green.

(b) By the addition to area No. 23 (relating to the village of Lapathos) of the following area :—

The Crown land under plot No. 274/1/2 of Sheet No. XIV, Plan No. 56 at the locality "Kouccolatjia", demarcated by boundary stones numbered consecutively from 1-54 inclusive, comprising 124 donums or thereabouts and shown on the Government Survey Plan Serial No. 1696, delineated thereon in green.

THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CYPRUS) ORDER, 1946.

REVOCATION OF ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.
