ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 12th October, 1956, and published in Supplement No. 3 to the *Gazette* of the 18th October, 1956, under Notification No. 984 (as amended by Notification No. 57 published in Supplement No. 3 to the *Gazette* of the 17th January, 1957) (hereinafter referred to as "the Order"), His Excellency the Governor has authorised the use for military purposes of the land and property set out in the Second Schedule to the Order, situated in Larnaca Town (hereinafter referred to as "the land"), subject to the restrictions and conditions therein laid down for a period of six months ;

And whereas by virtue of Notifications Nos. 399 and 901 published in Supplement No. 3 to the *Gazettes* of the 11th April, 1957, and 3rd October, 1957, respectively, the Order was extended for further periods of six months up to the 11th April, 1958 ;

And whereas the Governor is satisfied that the land should continue to be used for military purposes for a further period of six months :
