

- (iii) the election expenses of a candidate for any election outside the Force ;
- (iv) the funds of any body or organisation outside the Force ;
- (v) benevolent or charitable expenses except with the express approval of the Governor ;
- (vi) to defray any expenses incurred by or on behalf of any member of the Force in respect of any criminal or disciplinary proceedings against him.
- (e) The funds of the Association may be used—
  - (i) to pay expenses incurred in connection with Meetings of the Association ;
  - (ii) to pay expenses incurred by representatives in attending Meetings of the Association Committee which are not chargeable to public funds ;
  - (iii) for such other purposes as the Chief Constable may approve.

THE POLICE LAW, 1958.

RULES MADE UNDER SECTION 52 (4).

In exercise of the powers vested in him by section 52 (4) of the Police Law, 1958, His Excellency the Governor, with the advice of the Executive Council, has been pleased to make the following rules :—

1. These Rules may be cited as the Cyprus Police Association Rules, 1958, and shall come into force on the first day of May, 1958.

2. The Cyprus Police Association (in these Rules referred to as "the Association") shall consist of all members for the time being of the Force below the rank of Assistant Superintendent and the Association shall act through the committees as hereinafter provided.

3. There shall be constituted three committees, one for Constables, one for Sergeants and one for Inspectors, to be called the "Constables' Committee", the "Sergeants' Committee" and the "Inspectors' Committee", respectively.

4. The Committee shall consist of one member for each Division elected by members of the Force for the rank in question belonging to that Division. For the purposes of these Rules the following shall be deemed to constitute the Divisions :—

- (a) Nicosia, Limassol, Famagusta, Larnaca, Paphos, Kyrenia, Lefka and Troodos Divisions ;
- (b) Headquarters Division (including Headquarters Departments and Training School) ;
- (c) Mobile Reserve Division (including Mobile Reserve Headquarters and Mobile Reserve Units stationed at Nicosia) ;
- (d) Port and Marine Division (including Port and Marine Headquarters, Famagusta) ;
- (e) Fire Service (including all fire service units throughout the Colony) :

Provided that save as provided in paragraph (c) of this rule members of the specialist departments (Mobile Reserve, Criminal Investigation Department, Special Branch, etc.) shall be eligible for election in the Division to which they are attached.

5. All Police Officers of each rank shall have the right to vote at an election of the committee for that rank.

Provided that any police officer attached to any Division who at the time of the election is at the Police Training School or temporarily transferred away from his Division shall vote for his Divisional candidate and

not for the candidate of the Division to which he is temporarily attached.

6. The elections shall take place biennially in September on a day fixed by the Chief Constable and the annual meetings of all committees shall be held not later than the seventh day of October each year on a day fixed by the Chief Constable.

7. The three committees or any two of them may by agreement sit together as one committee, to be known as the "Joint Committee", for any special purpose or regularly for all purposes of common interest.

8.—(1) A committee or the joint committee may submit representations in writing to the Chief Constable and to the Governor through the Chief Constable.

(2) A committee or the joint committee shall consider and report upon any matter referred to it by the Chief Constable.

9. A committee or the joint committee in addition to submitting any representation to the Chief Constable or the Governor may submit it also to the Secretary of State through the normal channels.

10. All elections shall be by secret ballot. At any election conducted under these Rules each elector may give one vote and no more for one of the candidates of his rank in his Division.

11. Subject to the provisions of these Rules each committee may make regulations as to the mode of election of the members of the committee and as to the filling of casual vacancies amongst such members :

Provided that any Regulations made by each committee under rule 11 of the Cyprus Police Association Rules, 1953 to 1956, revoked hereby shall continue in force until amended or revoked by Regulations made under this Rule by the respective committees :

Provided further that when the membership of a committee or of the joint committee falls below half its membership the Chief Constable shall have the power to order new elections.

12. Each committee and joint committee shall choose its chairman and secretary from among its members.

13. The chairman at any meeting of the committee or the joint committee at which he is present shall have a second or casting vote.

14. Subject to the provisions of these Rules, every committee or the joint committee may regulate its own procedure including the appointment of sub-committees.

15. Committees may hold four quarterly meetings (including the annual meeting) at such place as may be convenient, but additional meetings for any special purpose may be held with the consent of the Chief Constable :

Provided that a Divisional Joint Inspectors', Sergeants' and Constables' Committee, from time to time and with the approval of the Divisional Commander may—

- (a) discuss any matter which is within the powers given to them by these Rules and the Law ; and
- (b) under the chairmanship of a Gazetted Officer discuss and make recommendations affecting welfare and sport within such Division and may, for this purpose, co-opt not more than two members of the Force of the same Division.

16.—(a) The Association may raise funds by subscriptions among its members, and may collect subscriptions from its members to meet its expenses. Donations shall only be accepted from members of the Association.

(b) The rate of subscription payable by the members shall be decided at the Annual General Meeting.

(c) The Committee shall keep detailed accounts of any subscriptions or donations paid to it and shall have them audited by an independent auditor. An annual Statement of Account shall be available at the Annual General Meeting. The Governor or the Chief Constable may at any time call for a copy of such Statements of Account or any books kept in connection with the affairs of the Association.

(d) The funds of the Association shall not be used for contributing directly or indirectly to—

- (i) the funds of a trade union ;
  - (ii) the funds of a political party ;
  - (iii) the election expenses of a candidate for any election outside the Force ;
  - (iv) the funds of any body or organisation outside the Force ;
  - (v) benevolent or charitable expenses except with the express approval of the Governor ;
  - (vi) defray any expenses incurred by or on behalf of any member of the Force in respect of any criminal or disciplinary proceedings against him.
- (e) The funds of the Association may be used—
- (i) to pay expenses incurred in connection with Meetings of the Association ;
  - (ii) to pay expenses incurred by representatives in attending Meetings of the Association Committee which are not chargeable to public funds ;
  - (iii) for such other purposes as the Chief Constable may approve.

17. Except where, in special circumstances, an officer of police is required for duty for which no substitute is available, leave shall be given for attendance, at all such meetings duly held and every such attendance, as regards allowances and expenses, shall be deemed to be an occasion of police duty.

18. The Cyprus Police Association Rules, 1953 to 1956, are hereby revoked :

Provided that all members of the three committees elected under the provisions of the said Rules shall be deemed to have been elected under rule 6 of these Rules and shall remain in office until the next elections held under these Rules.

**THE POLICE LAW, 1958.**

**DIRECTION UNDER SECTION 25 (3).**

In exercise of the powers vested in him by sub-section (3) of section 25 of the Police Law, 1958, His Excellency the Governor has been pleased to direct that the proceeds of the sale of any unclaimed property sold under the provisions of the said section shall, if no claim to such property has been established within the period mentioned in the said section and after the deduction of any expenses incurred by such sale, be disposed of as follows:—

- (a) Fifty per centum of the proceeds shall be paid into the general revenue of the Colony ;
- (b) Twenty-five per centum of the proceeds shall be paid into the Police Fines and Rewards Fund ;
- (c) Twenty-five per centum of the proceeds shall be paid to the finder of the property in question :

Provided that if such finder is a member of the Force the said twenty-five per centum of the proceeds shall also be paid into the Police Fines and Rewards Fund.
