

thousand two hundred and fifty pounds (£1,250) at a rate of interest not exceeding five per centum (5%) per annum, subject to the following terms and conditions, that is to say:—

- (a) the sum borrowed shall be repayable by the Board to the Lenders in ten equal annual instalments (comprising sinking fund and interest);
- (b) the sum borrowed shall be utilized by the Board for—
- (i) asphaltting the road to the Troodos Club;
 - (ii) providing a car-park; and
 - (iii) repairing the tennis courts at the Club.
2. For the purpose of securing the repayment of the sum under the loan, the Board shall, subject to any prior mortgage thereon, mortgage to the Lenders all the rates, fees, rents, tolls or charges now payable or hereafter to become payable to the Board.

No. 345. THE LAND ACQUISITION LAW.

NOTIFICATION UNDER SECTION 7.

Whereas by Notification No. 107 published in Supplement No. 3 to the *Gazette* of the 16th February, 1956, the Governor declared the widening, improving and realigning of the public road between Nicosia and Limassol to be an undertaking of public utility ;

And whereas the Commissioner of Larnaca in compliance with section 6 of the Land Acquisition Law, by a notice published under Notification No. 207 in Supplement No. 3 to the *Gazette* of the 27th March, 1958, gave particulars of a portion of the lands required in connection with the aforesaid undertaking (hereinafter referred to as "the lands");
