ORDER IN COUNCIL No. 2994

MADE UNDER SECTION 124 (1).

Authority to the Council of the Municipal Corporation of Nicosia to contract a loan.

Whereas by Order in Council No. 2971 dated 28th October, 1957, published under Notification No. 984 in Supplement No. 3 to the *Gazette* of the 7th November, 1957 (hereinafter referred to as "the principal Order"), authority was given to the Municipal Corporation of Nicosia to contract a loan of £35,000 subject to the terms and conditions specified therein ;

And whereas it is found desirable to amend the principal Order :

Now, therefore, in exercise of the powers vested in him by section 124 (1) of the Municipal Corporations Law, and of every other power thereunto enabling, His Excellency the Governor, with the advice of the Executive Council, has been pleased to order as follows :—

Paragraph (a) of clause 1 of the principal Order is hereby amended by the addition at the end thereof of the following (the semi-colon at the end of paragraph (a) being substituted by a comma) "or two years after the execution of the agreement between the Lender and the Municipal Corporation, whichever is the earlier ;".
