THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955 TO (No. 3) 1958.

ORDER MADE UNDER REGULATION 44.

Whereas it appears to the Governor to be expedient in the interest of public order and safety to take possession of the land described in the Schedule hereto (hereinafter referred to as "the land") and to authorise its use in the interest of public order and safety:

Now, therefore, in exercise of the powers vested in him by regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, His Excellency the Governor has been pleased to take possession of the land and, in connection with the taking possession and making use of the land, has been pleased to direct and order as follows:—

- (1) The use of the land for the purpose of establishing and maintaining a Detention Camp and for purposes pertaining thereto is hereby authorised.
- (2) The persons using the land in pursuance of this Order are hereby authorised to do, in relation to the land, anything which any person having an interest in the land would be entitled to do by virtue of that interest.

- (3) The exercise of any right of way over the land, and of any other right relating thereto which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited.

This Order shall come into force on the 31st day of July, 1958.

SCHEDULE.

The whole of plot No. 102 of Block C, Ayios Loukas quarter, Famagusta, with everything standing thereon, part of which is known as the old Municipal Petroleum Stores, which is delineated in red on the plan signed by the Commissioner, Famagusta, and dated 31st July, 1958, and kept in his office at Famagusta.

**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 3) 1958.**

ORDER MADE UNDER REGULATION 34.

In exercise of the powers vested in me by paragraph (b) of Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, I, the Commissioner of Nicosia, do hereby make the following Order :—

1. This Order may be cited as the Control of Bicycles (Nicosia District No. 3) Order, 1958.
2. The use or circulation of any bicycle within the area set out in the Schedule hereto is hereby prohibited except under the authority of a written permit granted by me or by the officer in charge of Nicosia Police Division :
Provided that this paragraph shall not apply to—
 - (a) members of Her Majesty's Forces;
 - (b) members of the Cyprus Police Force (as defined in the Police Law) when on duty as such;
 - (c) persons who can prove that they are under the age of ten years or over the age of twenty-seven years.
3. No bicycle shall be left in any road or any place to which the public have access in the area specified in the Schedule hereto.
4. This Order shall come into force at 0430 hours on the twenty-fourth of July, 1958.

SCHEDULE.

The Municipal Area of Nicosia, the Improvement Board Areas of Strovolos, Ayios Dhometios, Kaimakli, Palouriotissa, and the Village Areas of Engomi, Trakhonas, Eylenja, Orta Keuy and Omorphita.
