**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 3) 1958.**

ORDER UNDER REGULATION 34.

In exercise of the powers vested in me by paragraph (b) of Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, I, the Commissioner of Nicosia, do hereby make the following Order :—

1. This Order may be cited as the Control of Bicycles (Nicosia District No. 4) Order, 1958.
2. The use or circulation of any bicycle on any road within the area set out in the Schedule hereto is hereby prohibited except under the authority of a written permit granted by me or by the officer in charge of Nicosia Police Division :
Provided that this paragraph shall not apply to—
 - (a) Members of Her Majesty's Forces.
 - (b) Members of the Cyprus Police Force (as defined in the Police Law) when on duty as such.
 - (c) Persons who can prove that they were born before the first day of August, 1931, or after the thirty-first day of July, 1948.
3. No bicycle shall be left in any road or any place to which the public have access in the area specified in the Schedule hereto.
4. This Order shall come into force at 0430 hours on the twenty-fourth day of July, 1958.
5. The Control of Bicycles (Nicosia District No. 3) Order, 1958, is hereby revoked.

SCHEDULE.

The Municipal Area of Nicosia, the Improvement Board Areas of Strovolos, Ayios Dhometios, Kaimakli, Palouriotissa, and the Village Areas of Engomi, Trakhonas, Eylenja, Orta Keuy and Omorphita.

ORDER UNDER REGULATION 34.

In exercise of the powers vested in me by paragraph (b) of Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, I, the Commissioner of Famagusta, do hereby make the following Order :—

1. This Order may be cited as the Famagusta District (Control of Bicycles) (No. 1) Order, 1958.
2. The use or circulation of any bicycle by males on any road within the area set out in the Schedule hereto is hereby prohibited except under the

authority of a written permit granted by me or by the officer in charge of Famagusta Police Division:

Provided that this paragraph shall not apply to—

- (a) Members of Her Majesty's Forces.
 - (b) Members of the Cyprus Police Force (as defined in the Police Law) when on duty as such.
 - (c) Persons who can prove that they are under the age of ten years or over the age of twenty-seven years.
3. No bicycle shall be left in any road or any place to which the public have access in the area specified in the Schedule hereto.
4. This Order shall come into force on 24th July, 1958.

ORDER UNDER REGULATION 34.

In exercise of the powers vested in me by paragraph (b) of Regulation 34 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, I, the Commissioner of Famagusta, do hereby make the following Order:—

- 1. This Order may be cited as the Famagusta District (Control of Bicycles) (No. 2) Order, 1958, and shall come into force on the 28th day of July, 1958.
- 2. The use or circulation of any bicycle by any person, male, or female, within the area set out in the Schedule hereto is hereby prohibited except under the authority of a written permit granted by me or by the officer in charge of Famagusta Police Division :
Provided that this paragraph shall not apply to—
 - (a) Members of Her Majesty's Forces.
 - (b) Members of the Cyprus Police Force (as defined in the Police Law) when on duty as such.
 - (c) Persons who can prove that they are under the age of ten years or over the age of twenty-seven years.
- 3. No bicycle shall be left in any road or any place to which the public have access in the area specified in the Schedule hereto.
- 4. The Famagusta District (Control of Bicycles) (No. 1) Order, 1958, is hereby revoked.
