

No. 694. THE WIRELESS TELEGRAPHY LAWS,
1952 AND 1955.

ORDER MADE UNDER SECTION 3 (1).

In exercise of the powers vested in him by the proviso to sub-section (1) of section 3 of the Wireless Telegraphy Laws, 1952 and 1955, the Governor's Deputy has been pleased to order as follows :—

1. This Order may be cited as the Wireless Telegraphy (Republic of Turkey) (Exemption) Order, 1958.

2. The establishment, installation, use and maintenance by the Government of the Republic of Turkey of the wireless telegraphy apparatus specified in the Schedule hereto is hereby exempted from the provisions of sub-section (1) of section 3 of the Wireless Telegraphy Laws, 1952 and 1955.

No. 695. THE EMERGENCY POWERS (PUBLIC SAFETY AND
ORDER) REGULATIONS, 1955 TO (No. 3) 1958.

ORDER MADE UNDER REGULATION 44.

Whereas it appears to the Governor to be necessary in the interest of public safety and order to take possession of the land described in the Schedule to this Order :

Now, therefore, in exercise of the powers vested in him by regulation 44 of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, notice is hereby given that the Governor has taken possession of all the land specified in the Schedule hereto.

Any member of Her Majesty's Forces is hereby authorised to do in relation to the land anything which the owner or any person having an interest in the land would be entitled to do by virtue of such ownership or interest, as may be necessary for security purposes.

The exercise of any right relating to the land which is enjoyed by any person, whether by virtue of an interest in the land or otherwise, is hereby prohibited during the period this order shall remain in force.

SCHEDULE.

All that area of privately-owned land with everything standing thereon, situated at Xylymbou village, under plot No. 99 and part of plot Nos. 102.1

and 102.2 of the Government Survey Plan, Sheet XXXII, Plan 59, and part of Plot Nos. 214/3/1, 214/4/1 and 214/4/2 of the Government Survey Plan, Sheet XXXII, Plan 60 more particularly defined as the area delineated in red on the plan signed by the Commissioner, Larnaca, and dated the 29th August, 1958, a copy of which is available for inspection at the office of the Commissioner, Larnaca.

**THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER)
REGULATIONS, 1955 TO (No. 3) 1958.**

ORDER MADE UNDER REGULATION 60A.

Whereas I consider it expedient in the interests of Public Safety to make a clearance order in respect of the land described in the Schedule hereto :

Now, therefore, I, the Commissioner of Nicosia, in exercise of the powers vested in me by Regulation 60A of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, do hereby order as follows :—

1. This order may be cited as the Emergency Powers (Clearance) (Nicosia District) (No. 1) Order, 1958.

2. The owners and occupiers of the land described in the Schedule hereto (hereinafter referred to as "the land"), and the agents of such owners and occupiers, are hereby directed :—

- (a) to cut and clear away from the land all herbage, bush and undergrowth ;
- (b) to prevent any herbage, bush or undergrowth on the land from growing higher than one foot and to maintain the land in a clear condition to the satisfaction of the Area Commander, Nicosia ;
- (c) to cut flush with the trunk and clear away the branches of all Cypress trees standing on the land to a height of twelve feet from ground level, and of all fruit trees to a height of six feet from ground level ;
- (d) to cut and clear away such Eucalyptus and Acacia trees or branches thereof as may be indicated by the Area Commander, Nicosia.

SCHEDULE.

The area of land abutting on or lying within a distance of fifty yards of the following sections of public roads :—

1. From Nicosia to the District Boundary on the main Nicosia-Lefkoniko road.
2. From Kythrea southwards to Palekythro.
3. From Voni northwards to the main Nicosia-Lefkoniko road.
4. From Nicosia to the District Boundary on the main Nicosia-Larnaca Road at the 16th milestone.
5. From Potamia north-eastwards to the main Nicosia-Larnaca Road at Pyroi.
6. From Louroujina north-eastwards to the main Nicosia-Larnaca Road.
