ORDER IN COUNCIL No. 3032

MADE UNDER SECTION 7(1)(e).

Whereas the Maronite Archbishop of Cyprus has applied to the Loan Commissioners for a loan for the purpose of erecting buildings or otherwise improving the value of certain lands the property of the Maronite Church and situate in Cyprus ;

And whereas the Governor in Council is satisfied that the purpose aforesaid is a purpose tending to advance the development of the Colony ;

Now, therefore, in exercise of the powers conferred upon him by paragraph (e) of sub-section (1) of section 7 of the Public Loans Law, His Excellency the Governor, with the advice of the Executive Council, has been pleased to approve the granting of a loan not exceeding twenty-five thousand pounds by the Loan Commissioners to the Maronite Archbishop of Cyprus for the purpose of erecting buildings or otherwise improving the value of the lands described in the Schedule hereto.

No. 759. THE COURTS OF JUSTICE LAW, 1953.  
LAW 40 OF 1953.

ORDER MADE UNDER SECTION 26 (5).

No. 760. THE ADVOCATES LAWS, 1955 AND 1956.
