No. 83. THE BOMBARDMENT RANGE AREAS LAW.
CAP. 222 AND LAW 23 OF 1951.

NOTICE UNDER SECTION 2.

In exercise of the powers vested in him by section 2 of the Bombardment Range Areas Law, His Excellency the Governor hereby amends the notice published under Notification No. 558 in Supplement No. 3 to the *Gazette* of the 30th May, 1957 (as amended by Notification No. 791 published in Supplement No. 3 to the *Gazette* of the 15th August, 1957), as follows:—

1. By the substitution for the paragraph appearing under the heading "The Akrotiri (No. 2) Bombardment Range Area" in the First Schedule to the said notice of the following new paragraph:—

"That area of the territorial waters of Cyprus bounded by a line drawn through the following positions on Admiralty Chart No. 2074 of the 15th October, 1954:—

THE VEGETABLE AND FLOWER SEED PRODUCTION LAW.
CAP. 179.

NOTICE UNDER SECTION 3.

In exercise of the powers vested in him by section 3 of the Vegetable and Flower Seed Production Law, the Governor's Deputy has been pleased to declare the village areas of Avlona and Evrykhou, in the Nicosia District, to be scheduled areas and the cauliflower and broad bean plants grown therein to be prescribed crops for the purposes of this Law.

THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.

REVOCATION OF ORDER MADE UNDER DEFENCE REGULATION 64.

In exercise of the powers vested in him by Defence Regulation 64, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946 (which continues in force in consequence of the Supplies and Services (Continuance) Order, 1957), the Governor's Deputy hereby revokes the Order made under Defence Regulation 64 and published under Notification No. 945 in Supplement No. 3 to the *Gazette* of the 4th October, 1956 (as extended by Notifications Nos. 302 and 857 in Supplement No. 3 to the *Gazettes* of the 21st March, 1957 and 12th September, 1957, respectively) without prejudice to anything done or left undone thereunder.
