CAP. 145.

NOTIFICATION UNDER SECTION 4.

In exercise of the powers vested in him by section 4 of the Quarantine Law, Cap. 145, or otherwise, His Excellency the Governor is pleased to declare and hereby declares that Local Areas in the first column of the Schedule hereto are infected local areas and that all passengers and goods therefrom shall, as from the date hereof, be subjected to the measures prescribed by the Quarantine (Maritime and Aerial) Regulations, 1953 and 1954, with respect to the dangerous infectious diseases in the second column of the said Schedule.

The Notification No. 32 published in Supplement No. 3 to the *Gazette* of 19th January, 1956, is hereby cancelled.

No. 87. THE LAND ACQUISITION LAW.
CAP. 233 AND LAWS 26 OF 1952 AND 22 OF 1956.

NOTICE UNDER SECTION 6.

With reference to Notification No. 24 published in Supplement No. 3 to the *Gazette* of the 16th January, 1958, notice is hereby given that the following lands are required for the undertaking of public utility mentioned therein:—

1. All that area of privately-owned land with everything standing thereon comprising 76 donums or thereabouts in the "Lakkia" locality of Tokhni and Zyyi villages, on the Government Survey Plan, Sheet LV plan 37, and more particularly defined as the area edged in pink and marked "A" on the plan signed by the Assistant Director, Lands, Cyprus, and dated the 20th January, 1958.

2. Any person claiming to have any right or interest in the said lands, who objects to the acquisition, is required within ten days from the date of the publication of this notice to send to me a statement of his right and interest and of the evidence thereof and of any claim made by him in respect of such right or interest.

3. Her Majesty's Government in the United Kingdom is willing to treat for the acquisition of the said land.

4. A plan showing the lands described above is available for inspection at my office.

5. The period mentioned in paragraph 2 hereof has been abridged to ten days with the approval of His Excellency the Governor.

6. Notification No. 75 in Supplement No. 3 to the *Gazette* of the 6th February, 1958, is hereby cancelled.

THE VILLAGES (ADMINISTRATION AND IMPROVEMENT)
LAWS, 1950 AND 1953.

BYE-LAWS MADE BY THE IMPROVEMENT BOARD OF ARADHIPPOU.

In exercise of the powers vested in them by section 24 of the Villages (Administration and Improvement) Laws, 1950 and 1953, the Improvement Board of Aradhippou hereby make the following Bye-laws:—

1. These Bye-laws may be cited as the Villages (Administration and Improvement) Aradhippou (Amendment) Bye-laws, 1958, and shall be read as one with the Villages (Administration and Improvement) Aradhippou Bye-laws, 1951 to 1957 (hereinafter referred to as "the principal Bye-laws"), and the principal Bye-laws and these bye-laws may together be cited as the Villages (Administration and Improvement) Aradhippou Bye-laws, 1951 to 1958.

2. The principal Bye-laws are hereby amended by the insertion therein, immediately after Bye-law 135, of the following bye-law:—

"135A. No person shall store or cause to be stored within the improvement area any hides or skins except in such stores and at such places as may by public notification be appointed by the Board".

The above Bye-laws have been approved by the Administrative Secretary.
