**THE RENT (CONTROL) LAW, 1954.**  
**LAW NO. 13 OF 1954.**

**APPOINTMENTS TO RENT ASSESSMENT BOARDS UNDER SECTION 10.**

In exercise of the powers conferred upon him by sub-section (1) of section 10 of the Rent (Control) Law, 1954, the Governor hereby makes the appointments following:—

- Mr. Michael Antoniou Michaelides to be President of the Rent Assessment Board for the rent restriction area of Larnaca *vice* Mr. Ioannis Limnatis ;
  - Mr. Bodamializade Hussein Ekrem to be President of the Rent Assessment Board for the rent restriction area of Famagusta *vice* Mr. Michael Antoniou Michaelides ;
  - Mr. Moustafa Fazil Plumer to be President of the Rent Assessment Board for the rent restriction area of Limassol *vice* Mr. Demetrios Demetriou Kakathimis ;
  - Mr. Ahmet Sami, M.B.E., to be a member of the Rent Assessment Boards for the rent restriction areas of Nicosia and Kyrenia ;
  - Mr. Hussein Siret to be a member of the Rent Assessment Board for the rent restriction area of Larnaca ; and
  - Mr. Nedjmi Moustafa to be a member of the Rent Assessment Board for the rent restriction area of Paphos.
2. The Schedule to Notification No. 490 published in Supplement No. 3 to the *Gazette* of the 31st July, 1958, is amended accordingly.

**No. 907. THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955 TO (No. 3) 1958.**

**ORDER MADE UNDER REGULATION 39A.**

Whereas I, the Commissioner of the District of Famagusta, am satisfied that the building described in the Schedule hereto (hereinafter referred as "the building") is a building which is being used by terrorists, now, therefore, in exercise of the powers vested in me by Regulation 39A of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 3) 1958, with the approval of the Governor, I do hereby order as follows:—

1. This Order may be cited as the Emergency Powers (Forfeiture and Demolition) (Famagusta District) (No. 11) Order, 1958, and shall come into force on the 9th October, 1958.
2. It is hereby directed that the building described in the Schedule hereto and its contents be forfeited and demolished.

**SCHEDULE.**

The walls and trees surrounding the football ground at Paralimni village in Famagusta District, standing on Plot Nos. 192, 191, 215, 214, 216, 213, 212, 211, 210, 388 and 389 of the Government Survey Plan under Sheet XXXIII.62 and on Plot No. 362 of the Government Survey Plan (village) under Sheet XXXIII.54, more particularly defined as the boundaries bordered red on the plan signed by the Commissioner of Famagusta and dated the 9th October, 1958.
