

No. 908. THE EMERGENCY POWERS (PUBLIC SAFETY AND ORDER) REGULATIONS, 1955 TO (No. 5) 1958.

ORDER MADE UNDER REGULATION 39A.

Whereas I, the Assistant Commissioner of the District of Kyrenia, am satisfied that the building described in the Schedule hereto (hereinafter referred to as "the building") is a building which is being used by terrorists, now, therefore, in exercise of the powers vested in me by Regulation 39A of the Emergency Powers (Public Safety and Order) Regulations, 1955 to (No. 5) 1958, with the approval of the Governor, I do hereby order as follows :—

1. This Order may be cited as the Emergency Powers (Forfeiture and Demolition) (Kyrenia District) (No. 1) Order, 1958, and shall come into force on the 24th day of October, 1958.
2. It is hereby directed that the building and its contents be forfeited and demolished.

SCHEDULE.

The building situated at Karavas (Petroyitonia Quarter) in the District of Kyrenia standing on Plot No. 425/2, of Government Survey Plan XI/16E and registered under No. 5235.

**No. 909. THE CURFEWS LAWS, 1955.
LAWS 17 AND 47 OF 1955.**

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Nicosia District) (No. 64) Order, 1958.
2. No Greek Cypriot male or female born between the 1st January, 1932, and 1st January, 1944, both dates inclusive, shall be out of doors within the area prescribed in the First Schedule hereto, between the hours prescribed in the Second Schedule, except under the authority of a written permit granted by the Commissioner of Nicosia or the Assistant Chief Constable in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, the Cyprus Police Force on duty, or persons holding a summons to appear before a Special Court, established under the Special Court Laws, 1955 to 1957, when proceeding to and from such Court in accordance with such summons.

3. This Order shall come into force at 1800 hours on the 21st October, 1958.

FIRST SCHEDULE.

The Municipal area of Nicosia and the Improvement Board areas of Strovolos, Ayios Dhometios, Kaimakli and Palouriotissa, the Village areas of Trakhonas, Omorphita, Engomi, Orta Keuy and Eylenja.

SECOND SCHEDULE.

From 1800 hours to 0500 hours nightly until further notice.

THE CURFEWS LAWS, 1955.

LAWS 17 AND 47 OF 1955.

ORDER MADE UNDER SECTION 2.

In exercise of the powers vested in the Governor by section 2 of the Curfews Laws, 1955, and delegated to me under section 2A of the said Laws by Notification No. 666 published in Supplement No. 3 to the *Gazette* of 19th July, 1956, I do hereby order as follows :—

1. This Order may be cited as the Curfews (Nicosia District) (No. 65) Order, 1958.

2. No Greek Cypriot male or female born between the 1st January, 1932, and 1st January, 1944, both dates inclusive, shall be out of doors within the area prescribed in the First Schedule hereto, between the hours prescribed in the Second Schedule except under the authority of a written permit granted by the Commissioner of Nicosia or the Assistant Chief Constable in charge of the area :

Provided that this Order shall not apply to any member of the Executive Council, Her Majesty's Forces, the Cyprus Police Force on duty, or persons holding a summons to appear before a Special Court, established under the Special Court Laws, 1955 to 1957, when proceeding to and from such Court in accordance with such summons.

3. This Order shall come into force at 1700 hours on the 23rd day of October, 1958.

FIRST SCHEDULE.

The Municipal area of Nicosia and the Improvement Board areas of Strovolos, Ayios Dhometios, Kaimakli and Palouriotissa, the village areas of Trakhonas, Omorphita, Engomi, Orta Keuy and Eylenja.

SECOND SCHEDULE.

From 1700 hours to 0500 hours nightly until further notice.
