**APPOINTMENT OF WELFARE OFFICERS UNDER SECTION 20 (1).**

**No. 357. THE LAND ACQUISITION LAW.  
CAP. 233 AND LAWS 26 OF 1952, 43 OF 1955 AND 22 OF 1956.**

**NOTICE UNDER SECTION 6.**

With reference to Public Instrument No. 107 of 1956, notice is hereby given that the following lands are required for the undertaking of public utility mentioned therein :—

Any person claiming to have any right or interest in the said lands who objects to the acquisition, is required within six weeks from the date of the publication of this notice to send to me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.

3. The Government is willing to treat for the acquisition of the said lands.

4. A plan showing the lands described above is available for inspection at my office.
