

No. 460. THE FORESHORE PROTECTION LAW.
CAP. 92 AND LAWS 16 OF 1954 AND 21 OF 1957.

NOTICE UNDER SECTION 3 (1).

In exercise of the powers vested in me by section 3 (1) of the Foreshore Protection Law, I hereby absolutely prohibit :—

- (a) the removal of stones, shingle, gravel, sand or other substance from all that area of the foreshore described in the Schedule hereto ;
- (b) the dumping of any rubble, rubbish, sweepings, litter, night-soil or other refuse upon any part of the foreshore described in the Schedule hereto ;
- (c) the dumping of any rubble, rubbish, sweepings, litter, night-soil or other refuse into the sea at any point opposite to the foreshore described in the Schedule hereto within a distance of 200 yards from low water mark.

SCHEDULE.

All that area of land at the locality "Avlaki" in the village of Ayios Epiktitos, in the District of Kyrenia, being parts of plots Nos. 32, 136, 117, 137, the whole of plot No. 138, parts of plots Nos. 128, 139, 141, 144, 207, 145 and 146 of the Government Survey Plan No. XIII.17, more particularly defined as the area delineated in red on the Government Survey Plan, Serial No. 1739, a copy of which is available for inspection at the Office of the Commissioner at Kyrenia.

**BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION
OF LEFKARA.**

In exercise of the powers vested in them by the Municipal Corporations Law and otherwise, the Council of the Municipal Corporation of Lefkara hereby make the following bye-laws :—

1. These Bye-laws may be cited as the Municipal Corporation (Lefkara) (Amendment) Bye-laws, 1959, and shall be read as one with the Municipal Corporation (Lefkara) Bye-laws, 1931 to 1957 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these Bye-laws may together be cited as the Municipal Corporation (Lefkara) Bye-laws, 1931 to 1959.

2. Paragraph (1) of Bye-law 133G of the principal Bye-laws (as set out in the Municipal Corporation (Lefkara) (Amendment) Bye-laws, 1957) is hereby deleted and substituted by the following paragraph :—

"133G.—(1) The owner, occupier or lessee of any premises, building or place within the municipal limits shall pay for the supply to him of 50 gallons of drinking water daily such sum as the Municipal Corporation may decide in each year but not exceeding £6.000 mls per annum as from the 1st January, 1960, and onwards in two equal instalments in advance every six months.

The above Bye-laws have been approved by His Excellency the Governor.
