THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS)
(CYPRUS) ORDER, 1946.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 29th May, 1956, and published as Public Instrument No. 438 of 1956, hereinafter referred to as "the Order", the Governor authorized the use of the land and property specified in the Order subject to the restrictions and conditions therein contained for military purposes during the period of six months commencing the 29th May, 1956;

And whereas by virtue of Public Instruments Nos. 1165 of 1956, 498 of 1957, 962 of 1957, 306 of 1958, 881 of 1958 and 257 of 1959 the Order was extended for further periods of six months up to the 28th November, 1959;

And whereas the Governor is satisfied that the land and property should continue to be used for military purposes for a further period of two months;

Now, therefore, in exercise of the powers conferred upon him by Defence Regulation 64 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, which continues in force by virtue of the provisions of the Supplies and Services (Transitional Powers) (Continuation) Laws, 1958 and 1959, His Excellency the Governor has authorized the use of the land and property specified in the Orders and subject to the restrictions and conditions therein contained for a further period of two months commencing the 29th November, 1959.

(CYPRUS) ORDER, 1946.

ORDER MADE BY THE GOVERNOR UNDER DEFENCE REGULATION 64.

Whereas by Order dated the 9th November, 1956, and published as Public Instrument No. 1115 of 1956, hereinafter referred to as "the Order", the Governor authorized the use of the land and property specified in the Order subject to the restrictions and conditions therein contained for military purposes during the period of six months commencing the 9th November, 1956;

And whereas by virtue of Public Instruments Nos. 499 of 1957, 965 of 1957, 302 of 1958, 884 of 1958 and 253 of 1959, the Order was extended for further periods of six months up to the 8th November, 1959;

And whereas the Governor is satisfied that the land and property should continue to be used for military purposes for a further period of three months:

Now, therefore, in exercise of the powers conferred upon him by Defence Regulation 64 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, which continues in force by virtue of the provisions of the Supplies and Services (Transitional Powers) (Continuation) Laws, 1958 and 1959, His Excellency the Governor has authorized the use of the land and property specified in the Orders and subject to the restrictions and conditions therein contained for a further period of three months commencing the 9th November, 1959.
