ORDER MADE UNDER SECTION 62.

Whereas by reason of the resignation of certain councillors of the Municipal Corporation of Lefkara (hereinafter referred to as "the said Corporation") the number of councillors of the said Corporation capable of acting has fallen below one-third of the total number of councillors as directed in accordance with the provisions of section 10 of the Municipal Corporations Law in respect of the said Corporation;

And whereas in consequence thereof the council of the said Corporation is deemed to have expired:

Now, therefore, in exercise of the powers vested in him by section 62 of the Municipal Corporations Law, His Excellency the Governor does hereby appoint a municipal commission consisting of the persons whose names appear in the Schedule hereto to have all the powers and to perform all the duties of the council of the said Corporation which has so expired, until another council shall be elected in accordance with the provisions of the said section 62 and does hereby appoint Mr. George S. Savvides, O.B.E., Commissioner, Larnaca, to be Chairman of the said commission during the same time and to have all the powers and perform all the duties of the mayor.

**THE GAME AND WILD BIRDS PROTECTION LAW.**  
 CAP. 98 AND LAWS 23 OF 1950, 3 OF 1953 AND 57 OF 1955.

ORDER MADE BY THE GOVERNOR UNDER SECTION 14.

In exercise of the powers vested in him by section 14 of the Game and Wild Birds Protection Law (as set out in section 3 of Law 57 of 1955), His Excellency the Governor has been pleased to order as follows:—

1. This Order may be cited as the Game and Wild Birds Protection (Relaxation) Order, 1960.

2. In this Order—

"permitted area" means any area set out in the Appendix to the Close Season (Permitted Areas) Order.

3. The operation of paragraphs (a) and (b) of section 14 of the Game and Wild Birds Protection Law (as set out in section 3 of Law 57 of 1955) is hereby suspended with regard to the shooting of duck, geese and snipe in and around lakes and marshes within a permitted area.

4. This Order shall remain in force until the 31st day of March, 1960, and shall then expire.
